Ordinance No. 2021-TO-007

ORDINANCE CONCERNING ESTABLISHING AN ACCOUNT TO ACCEPT ALLOCATIONS FROM THE ARP CORONAVIRUS LOCAL FISCAL RECOVERY FUND.

WHEREAS, Counties, Cities, and Towns will each receive an allocation of Coronavirus State and Local Fiscal Recovery Funds. Each local unit that receives an allocation from the Coronavirus Local Fiscal Recovery Fund under Section 603(C) of the Social Security Act, as added by Section 9901 of the ARP.

WHEREAS, a separate fund will be created with the fund name of ARP Coronavirus Local Fiscal Recovery Fund; Fund Number Range 176-199. Fund uses are described in Section 603(c) of the Social Security Act, as added by Section 9901 of the American Rescue Plan Act of 2021.

WHEREAS, uses of the fund are specified in Section 603(c) as follows:

"(1) USE OF FUNDS – Subject to paragraph (2), and except as provided in paragraphs (3) and (4), a metropolitan city, nonentitlement unit of local government, or county shall only use the funds provided under a payment made under this section to cover costs incurred by the metropolitan city, nonentitlement unit of local government, or county, by December 31, 2024

(A) to respond to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19) or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;

(B) to respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers of the metropolitan city, nonentitlement unit of local government, or county that are performing such essential work, or by providing grants to eligible employers that have eligible workers who perform essential work;

(C) for the provision of government services to the extent of the reduction in revenue of such metropolitan city, nonentitlement unit of local government, or county due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year of the metropolitan city, nonentitlement unit of local government, or county prior to the emergency; or

(D) to make necessary investments in water, sewer, or broadband infrastructure."

WHEREAS, this ordinance will create and the account for Recovery Fund. This Ordinance will be amended at a later date to include the required plan.

NOW THEREFORE LET IT BE ORDAINED AS FOLLOWS:


1. An account will be created by the Clerk/Treasure with the name of ARP Coronavirus Local Fiscal Recovery Fund; Fund Number Range of 176-199.
2. Use of funds are specified under Section 603(C) of the Social Security Act, as added by Section 9901 of the of the American Rescue Plan Act of 2021.
3. Ordinance will be amended at a later today to include a plan as required by Section 603.




