

TOWN OF GREENVILLE
ORDINANCE NO: 2023-TO-015

AMENDMENT TO ORDINANCE 2021-TO-15 (Codified Ordinances §70.07 and §70.99)

WHEREAS, the Town of Greenville, Indiana, passed 2010-TO-00049.

WHEREAS, the Town of Greenville, Indiana seeks to amend the Ordinance and has the authority to do so by I.C.36-5-2-10

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. 2021-TO-15 (Codified Ordinance §70.07) is hereby amended to read as follows:
PARKING GENERALLY is amended to add (J)(1)(a)8 to read, “8. Any public roads in the Heritage Springs Subdivision, including by not limited to Heritage Way, Frontier Trail, Pioneer Lane, Wagon Trail, Patriot Place, Conestoga Court and Freedom Court.

2. 2021-TO-15, SECTION 4 (Codified Ordinance §70.99(G)) shall be amended to read as follows:

(F) Parking Fines

Blocking driveway	\$25
Parking on sidewalk	\$25
Amount of fine if not paid after 30 days	\$100
Manner of parking – Section 7B	\$25
Owner’s responsibility for illegal parking -Section 7A	\$100
Parking within an intersection -Section 7C	\$100
Parking on a crosswalk – Section 7D	\$25
Parking from curblines and property lines – Section 7E	\$25
Parking in front of fire hydrant – Section 7F	\$100
Parking when prohibited for temporary reasons -Section 7G	\$25
Parking of vehicles that are not self-propelled – Section 7H	\$25
Overnight parking – Section 7I	\$100
Parking prohibited – Section 7J	\$25
The owner of a vehicle for which a violation has been issued shall be subject to a penalty of up to a maximum of \$100 per offense if not paid within 30 days from the date of the violation.	

(G) Any vehicle parked on a public roadway in violation of any section of this Ordinance is subject to towing at the violators expense.

3. This ordinance shall be effective upon publication as required by IC 5-3-1
