
The Council gave final reading to the 1992 Salary Ordinance. There being no objection the Council approved Salary Ordinance # 1992-01 by a vote of 3-0.

The Clerk Treasurers' financial report indicates the bank balances for the town/utility are correct.


The Council approved claims for the town/utility, Bond and payment for Gary.

DEAR MR. SPRIGLER,

I HAVE EXAMINED THE BOX CULVERT UNDER HARRISON STREET NEAR THE HOUSE LOCATED AT 9424 HARRISON STREET. I FIND IT TO BE 36" X 96", A SIZE THAT IS SUITABLE FOR THAT LOCATION. THE TOTAL DRAINAGE AREA TO THAT POINT IS BETWEEN 90 AND 100 ACRES WITH AN ESTIMATED RUN-OFF COEFFICIENT OF 0.7. THE MAJORITY OF THAT DRAINAGE AREA IS NORTH OF HWY 150, AND THE RESULTING STORM-WATER MUST PASS THROUGH A STRUCTURE SMALLER IN SIZE UNDER THAT ROAD BEFORE ARRIVING AT THE HARRISON STREET STRUCTURE.

THE HOUSE LOCATED AT 9424 HARRISON STREET AND THE NEARBY PROPERTY WOULD BE IN JEOPARDY IF THE BOX CULVERT SHOULD BECOME BLOCKED OR CLOGGED. THE NEARBY TREES WOULD BE THE MOST LIKELY SOURCE OF SUCH A BLOCKAGE (STORM-BROKEN LIMBS) SO I WOULD ADVISE THE RESIDENTS AT THAT ADDRESS TO DO WHAT THEY CAN TO MINIMIZE THAT POTENTIAL.
