The Board asked Gary Getrost to contact Floyds Knobs Water Co., and decided that to proceed we need a more firm commitment from Edwardsville Water Co.

Gary Getrost reported he is working on the second pump at the plant.

Jack Sprigler mentioned the need for a building to house the trucks, backhoe, and other equipment. The Board agreed and decided to investigate the possibilities.

Elaine Miller asked the Boards permission to order street signs for Glen Reisert Drive. Jack Sprigler moved that signs be purchased for Glen Reisert Drive. Ron Lamb seconded.

Janice Gibson reported Edwardsville Water Co. contacted her concerning putting their customers on the Greenville Water Utility computer. They have about 2,000 customers and it would involve billings only. The Board instructed Janice to check on the time element and to work out an estimate.

The Board chose First Midwest Bank and Trust as depository.

There being no further business the meeting was adjourned.
