MINUTES OF TOWN COUNCIL MEETING
March 12, 2002

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller with all Council Members present, as was the Clerk Treasurer Jack Sprigler and Deputy Clerk Treasurer Sheila Moore.

Also attending was Utility Superintendent Gary Getrost and Utility employee Janice Gibson and Clarion representative Mike Arnold.

Minutes of the February meeting was approved, with corrections: "Water Billing Adjustment approved 5-0" on motion by Mike Receveur.

Sheila Moore presented the Council with Ordinance G 2002-W-016 Titles "An Ordinance Establishing Rates and Charges for the Use of and Services Rendered by Waterworks System of the Town of Greenville". Council President Ted Miller then asked for a vote of the Council to accept Ordinance G 2002-W-016. On motion by David Matthews it was accepted and approved for consideration 5-0. After proper readings Miller then asked for a vote to pass Ordinance G 2002-W-016. On call of the roll David Matthews, Leon Gibson, Mike Receveur, Hanzel Barclay, all Council Members voted "Aye". Miller then voted "Aye" - Ordinance G 2002-W-016 duly passed by the Greenville Town Council to be effective after proper publication.

Council discussed changing meeting dates but decided to table the idea due to uncertain attendance problems.

Council also addressed office building maintenance and cleaning and directed Gary to follow up for repair or replacement of items needing attention.

Ted Miller read a letter from the New Albany/Floyd County Animal Control Board stipulating certain demands for the "drop off" of animals at the Animal Control facility. It was the Council's opinion that this board receives tax dollars from taxpayers of Greenville and the Town should not be subjected to additional monies. Also the letter was addressing Greenville Township. Council member David Matthews will check the letter contents with the appropriate government body.

Council accepted a contract from River City Controls for installation of water controls on the water towers. Council does not believe the cost of this project warrants bidding since it will be less than the required amount. Gary advised the Council that there is no other contractors in the area doing this type of work. Approved 5-0.

Gary apprised the Council he had received a request from Floyd County Emergency Management for installing Emergency Sirens on the top of the Utility's water towers. Council directed Ted Miller and Gary to check out the proposal and if it is legal and the particulars meet the Town's needs then Mr. Miller can proceed with necessary contracts.

No further business coming before the Council the meeting was adjourned on motion by Mike Receveur.
