

MINUTES OF GREENVILLE TOWN COUNCIL (Water Board) MEETING, March 25, 1998.

The Town Council meeting was opened by Council member Ted Miller with Council members Ray Gibson, Mike Receveur, Gerald Burkhart present at opening; Janet Riggs came in late.

Also attending was Dawn Foley, Tribune representative, attorney Jef Fifer, Tyco representatives Tod Sherrell and Bill Watts, Janice Gibson and Gary Getrost.

Ted Miller explained the utility's position as it pertains to new development. Mr. Miller proposed the Utility will secure estimated costs to enlarge the line on the Bradford Road, from the Greenville/Georgetown Road to the end of the Tyco property, from the present 4' line to 6" line with Tyco assuming the costs for that part of line that runs along their property. Watts questioned why the upgrade. Gary Getrost explained the reason for a larger line.

After estimated are received the Council will advise Tyco of the costs to them. The Council stated monies put up for such construction by Tyco can be held in escrow to insure those monies are spent for the project only.

Mr. Miller motioned the Town pay for a load of gravel that was spread on the parking lot by mistake by the Town. All members voted for approval. (5-0).

Mr. Miller apprised the Council of the meeting of March 25, 1998 with Krohn & Associated regarding a rate study being done by them for the Utility.

The Council, by a vote of 5-0, approved water bill adjustments as presented by the Utility Office manager.

No further business coming before the Council the Council adjourned at 8:45 P.M.
