The regular monthly meeting of the Greenville Town Board was called to order by President Robert Gibson. Those attending were all board members along with Dan Cristiani, William H. Cord, Max Mason, Jr., Janice Gibson, Robert Isgrigg, Virginia Ham and Gary Getrost.

The town board signed a letter of intent for pre-application for federal assistance for a 5% 40 year loan. The loan is to be used for Water Treatment Plant upgrading and repairs.

Minutes of the previous meeting were read and approved. Financial Reports were given to each board member.

Mr. Isgrigg will intervene for the Town of Greenville regarding water purchases through the Tri-County Water System.

Mr. Max Mason searched our contract with the Ramsey Water Company to determine if any clause existed whereas Ramsey Water Company can charge an estimated bill due to malfunctioning meters. He stated the contract states the Ramsey Water Co., can charge the previous months' usage unless agreement otherwise with the Greenville Water Company. On recommendation of the board the agreed upon bill for Ramsey Water co., is to be paid at the minimum bill.


Mr. Robert Gibson motioned the Town of Greenville appropriate \$11,000 for construction costs of the new building for the Town Hall and appropriate \$30,000 of Water Utility funds of the Greenville Water Utility for construction costs for the new Utility Office Building. The board accepted the bid of Thrasher Construction Company of \$42,000 for the building, contingent upon change orders as determined by the board. Ms. Pearl Tush seconded the motion and was also approved by the entire board.


Mr. Isgrigg informed the board the Edwardsville Water Company on April 3, 1979, approved a minimum purchase of 100,000 gal., per day not to exceed \$.75 per 1,000 gals., and that a contract will be entered into for a period not to exceed five (5) years.

The board approved the salary of V. Ham as <sup>Street Commissioner 4/18/79</sup> ~~Town Marshall~~ to be \$400.00 monthly.

No further business coming be fore the board Mr. Gibson motioned for adjournment, seconded by Pearl Tush.
