The regular monthly meeting of the Greenville Town Board, held this date, was called to order by President H.L. Spears. Present were all Board members, M. Mason, B. Isgrigg, J. Gibson, C. Getrost, V.J. Miller, M. Powell, Greg Wright, and Fred Grauel.

The minutes of the previous meeting were read and approved. Financial reports were presented to the board.

Greg Wright inquired about the status of the water line requested for Featheringill Road. The Board informed him the water company will not finance the line.

Fred Grauel requested a line extension to his property on Coffman Road. He has a grant from Floyd County to pay for the line if the water line will be extended rather than running a 1" line off a vacant meter. In either case he needs permission for right-of-way from Wayne Gahlinger. Gary Getrost, Ron Lamb, and Pat Houghlin will negotiate with Gahlinger.

Gary Getrost reported the gate is not being locked at the lake. Signs have been ordered. The road is fixed but still needs a couple loads of rock. The cost for repair is about \$1200. The State Board of Health called about low water and is sending someone to investigate.



The Board agreed not to appeal the Census Bureau estimate of population.


The Board approved having the Edwardsville and Floyds Knobs meters checked. The bill from Edwardsville was high. It is possible the meter is in error.
