MINUTES OF BOARD OF TRUSTEES, TOWN OF GREENVILLE

Ron Lamb, President of the Board, called the regular monthly meeting to order. All members were present. Also attending was Janice Gibson, Gary Getrost, Scott Ham, Bob Isgrigg, Talbott Richardson, Paul Buche, and Mildred Bierman.

Buck Spears motioned for approval of the March 8, minutes as presented, seconded by Ron Lamb.

Financial Statements were presented to Board members. The Clerk Treasurers' Report indicate that all bank and book balances are correct. Claims presented were approved in addition to charge off of delinquent water bills. (Attached).

Mildred Bierman submitted a preliminary drawing of a proposed subdivision to be located off Featheringill Road to be called Deerfield Subdivision.

Ms. Bierman stated the area will contain 32 lots and has not been approved by the Floyd County Plan Commission. Her appearance before the board was to request water service. Ron Lamb stated he could not forsee any problems with extending service but cautioned Ms. Bierman the Utility will need to coordinate such extension with the Utility engineer and Manager to determine line size and other pertinent data. Ms. Bierman was advised to notify the board upon approval or disapproval by the Floyd County Plan Commisssion.

Janice Gibson reported Don Perkins, local resident, has several cars parked on the sidewalk (counted six [6] cars on the property on April 11). Buck Spears questioned Talbott Richardson, the Town Marshall, on the situation. After some discussion Buck Spears recommended the board send Mr. Perkins a notice of violation of town ordinances by Certified Mail. The Clerk Treasurer was instructed to follow through.

Ms. Gibson also stated new residents in the house of John Riesert had several bags of garbage in front of their property located on Clark Street. The Marshall was instructed to contact those responsible.

The board was advised the owner of the quarry, Mr. Bodenbender, wants to use the quarry for a landfill. It was brought out by Talbott Richardson that he will use the fill for trees, rocks, concrete, etc., but no garbage. Ron Lamb perceived this could be problem and advised Mr. Richardson, who is in contact with Mr. Bodenbender, that Mr. Bodenbender will need to contact the county health department and obtain proper authority from all agencies responsible before the town can or will, approve such operation.

Paul Buche, the Deputy Marshall enlightened the board of the Marshalls' Department to engage in a program of Child Protection. The program will be enhanced by the use of audio and visual aids, with funding from federal and state grants. The board stated they wholeheardly support such a program and will offer assistance if needed.

Buck Spears questioned the Marshall of the availability of manuals addressing state and local laws. The Marshall stated we have the information but due to the rapid changes in the laws they may not be up to date. The Deputy Marshall stated the County Clerk has the Indiana Codes for our use but he uses the public library to research a specific code. He was instructed to check on the possibility of purchasing the Indiana Codes manual for their use, with payment coming from town funds.

Gary Getrost requested the town set up a dumpster again this year for use of town residents for disposal of trash (no garbage). The board stated funds are allocated and it is the boards' intention to do this every spring and fall.

The Manager, Town/Utility, advised the board the Indiana Department of Environmental Management approved the Floyds Knobs/Greenville Water Companies hook-up on Buck Creek Road. Mr. Getrost also stated he received information from the Edwardsville Water Company they do not object to Greenville Water Utility extending water service to Vale North Subdivision on the Old Vincennes Road. The board instructed Mr. Getrost to advise the developer of our decision and to coordinate the extension with them and with our engineer, and to inspect the actual construction to guarantee the job is done to our specifications.

Bob Isgrigg presented aerial map of the township to the board. The map, scaled 1"-500', will enable the utility in the location of fire hydrants, flush hydrants, line extensions, etc.

Ken Hartfield petitioned the board to vacate any alley between Lots 15 and 14, 20 and 24, 21 and 22, and part of 22 within the town. The board instructed the Clerk to proceed with the necessary advertising and ordinance preparation.

The board approved the appointment of Scott Ham as Lead Man, with \underline{no} increase in salary at the present time, at the request of the Manager, Town/Utility.

No further business coming before the board, Buck Spears motioned for adjournment, seconded by Ron Lamb.
