MINUTES OF TOWN COUNCIL MEETING

April 14, 2003

The regular monthly meeting of the Greenville Town Council was called to order by Council President L. Ray Gibson with Councilmembers David Matthews, Hanzel Barclay and Ted Miller present; Mike Receveur was absent. Also in attendance was Jack Sprigler, Clerk Treasurer, Utility Supt. Gary Getrost and Utility Clerk Janice Gibson, Denise Franke (Fifer Law Office), Marshal David Moore, and Kenny & Stacy Randolph owners of Town & Country Feeds.

Minutes of the March meeting was approved as read on motion of David Matthews.

Mr. & Mrs. Randolph stated they wanted to erect a sign in front of their business along U.S. 150. The sign will be using a frame now presently there from a previous sign. Ted Miller suggested they contact the highway department to see if there are any restrictions from the State. A copy of the Town ordinance pertaining to signs was given to them and were told to review is for guidance.

Council President Ray Gibson asked that bids received for the Utility truck be opened and read. Ted Miller opened each bid and noted as follows:

After discussion the Council stated the bids were rejected and are to be advertised again with a minimum bid of \$1,500, if this is legal, otherwise the truck is sold as is to the highest bidder.


Council voted 4-0 approving a Performance Bond addendum to Ordinance 2003-T-025.

Council accepted the resignation of Utility employee Shiela Moore.

Gary Getrost advised the Council the Utility needs to change specifications regarding water main extensions. He presented a memo to the Council explaining the details and asked for Council approval. He stated all extensions will be pipe of an 8" dia. Council approved 4-0.


