MINUTES OF TOWN COUNCIL MEETING, May 11, 1999.

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller at 7:50 p.m. with members Ray Gibson and Mike Receveur present; David Matthews was absent due to work schedule; and Clerk Treasurer Jack Sprigler.

Also attending was attorney Jef Fifer, Utility Superintendent Gary Getrost, Marshal David Moore, Greenville Postmaster Lillian Rhodes, Barbara Wood, Mike McKown, Jamie McKown, John Koerber and Mike Koerber.

Minutes of the April meeting was approved as read. (3-0)

Lillian Rhodes expressed opposition to Ordinance 1999-T-02; designating E. Harrison Street one way from Buttatown Road to Pekin Road, passed at the Council meeting in April citing various reasons such as increased chances of auto accidents, increased time for postal employees to start their routes and the impact it will have on Post Office traffic.

Mike Receveur stated he would contact the Floyd County Traffic engineer for a professional opinion on the establishment of the one-way street. Jef Fifer stated the Ordinance is in effect but until it is recorded no citations can be issued for violations. Mike stated he hopes to have the opinion by the next meeting at which time the Council can take any additional action.

Jamie McKown expressed concern of possible increased water run-off on his property should the Greenville Christian Church pave a parking lot adjoining his property. He stated he believed that should the church pave the lot they should install a gutter to direct any excess water run-off away from his property. Ted Miller stated that since the Town does not have zoning he believes the Town is powerless to dictate such an arrangement but that he would contact the church elders and advise them of McKown's concern.

The Council received a "Letter of Consent" dated 4/27/99 from Ananelle Eschman, Power of Attorney for Esther Ferber to proceed with removal of trees located on the Ferber property that are blocking water flow from E. Harrison Street.

Mike McKown, Parkland Heights resident, stated motorists are using his property to avoid a "chuck hole" in the street in front of him and would like the Council to vacate this part of the street so he could close this part. Ted Miller advised him the Council would look into the matter.

Marshal David Moore advised the Council that effective July 1, 1999 deputies will have to be paid overtime wages and as a result he was advising the Council not to hire any deputies.

John & Mike Koerber approached the Council for water service for a subdivision they are developing on Smith Road. The Koerbbers presented the Council with a Plat of the area for their review. After review the Council advised them Gary Getrost will follow up with costs associated with their request.



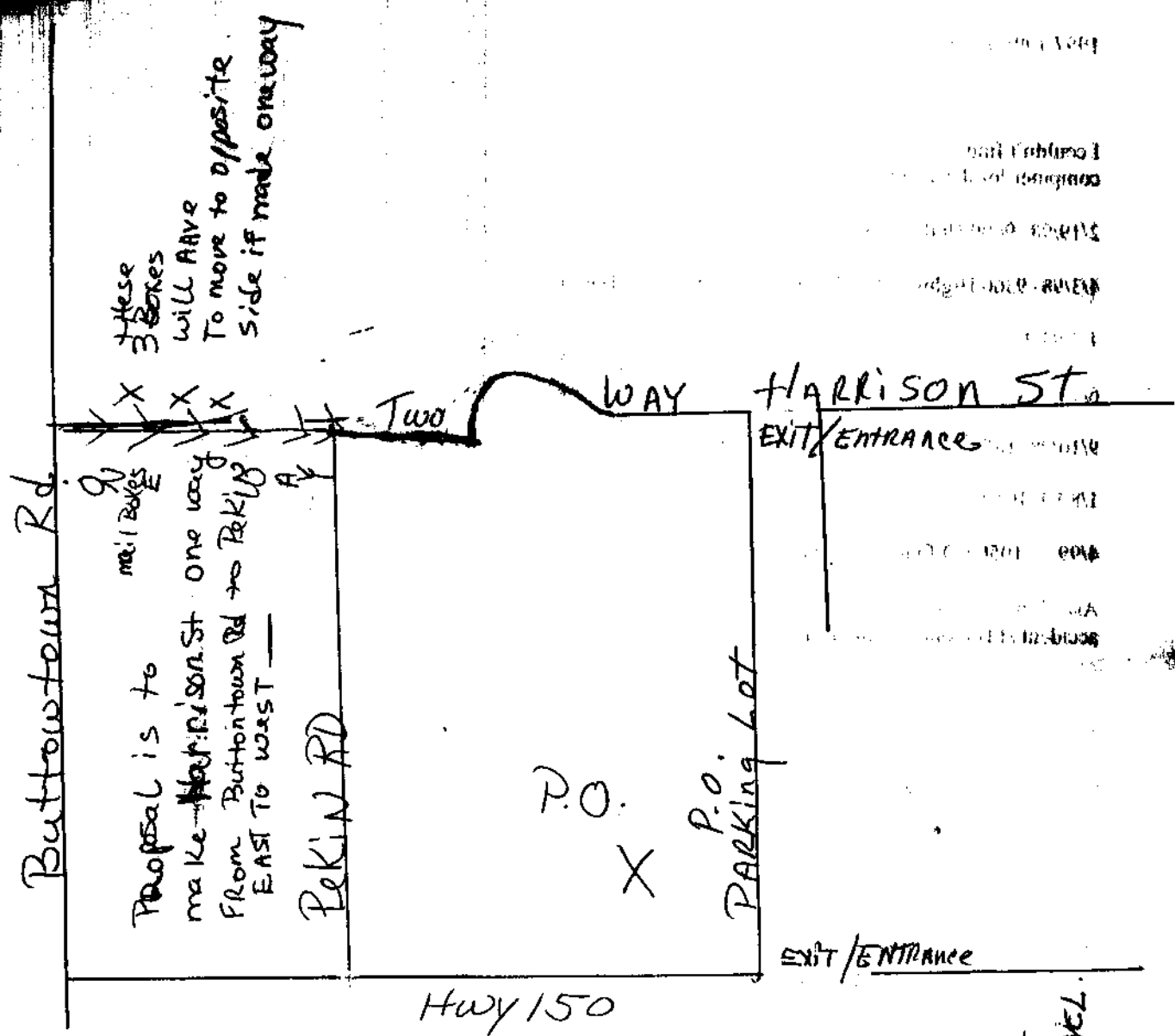
