The regular monthly meeting of the Greenville Town Board was opened by President Robert Gibson. In attendance was all board members and V. Ham, G. Getrost, J. Gibson and R. Isgrigg.

Minutes of the previous meeting was read and approved. Financial statements was presented to each board member.

Sprigler Bros. submitted to the board a bill for \$250.00 for driveway repair which was aproved by the board for payment.

President Gibson opened bids received on the new truck for the town. Bids submitted was: Graf Auto \$5,700, less trade in of 250.00 net \$5,450; Coyle Chev. LUV \$5,782.35, less trade in 790.00, net \$4,992.35; Jim ONeal Ford \$5,234.76 no trade in allowed. The board receomended the town take bids on a used truck if it is possible.

W. Miller requested permission to have a row boat on the lake. The board approved the use of flat bottom fishing boats (no motors) on the lake at a charge of \$5.00 per boat.

Mr. Isgrigg informed the board that the cost of water from Tri-County would be 89.3 cents including depreciation, without depreciation 81.9, with guarantee of certain gallons. Tri-County will provide emergency supply at .27 per 1,000. (For Fire, etc.) He recommended the board not sign a contract but to use the water for emergency use only. Greenville Water Utility should also supply Tri-county with water in case of emergency when feasable. Mr. Isgrigg also stated approval from the state has been received for the Borden water. He also informed the board that Edwardsville Water Company capacity would be up within 2 weeks and that he receommended a 6" line be run and that Greenville Water make connection and install meter.

No further business coming before the board Mr. Gibson motioned for adjournment, seconded by William Woyles.
