### ADDENDUM TO THE MONTHLY MEETING OF GREENVILLE TOWN BOARD

JULY 9, 1981

Mr. T. Richardson reported to the board on the condition of both the Greenville and alena towers. His findings:

Greenville tower:

The tower has a bad spot within the tank that could cause a rupture thus endangering the residents of the town causing loss of property and possibly life and injury.

The towers are in need of painting and treatment, which includes the Galena tower.

Due to the location of the Greenville tower and based on Mr. Richardsons' findings the Board declared that an emergency exzists.

Bids were solicited from these present. Mr. Achardson stated that he could submit a bid but declined. The board, in receipt of a bid from another vendor, not present, directed the Water Superintendent to contact the vendor to proceed with necessary repairs and painting, upon receipt of proper bid. Upon proper submission of bid by the vendor the board will meet in an emergency and consider the bid as submitted.

At your request my initial inspection of the Greenville Water Tank showed that the wax on the inside of the tank had broken down and that on the East side of the tank between the ladder and the drainpipe about 10 ft. up from the base of the tank there was a place about the size of a baseball, that showed signs of blowing out. This in my opinion put the tank into an emergency situtation. After the tank had been drained and a closer inspection was possible, I found the tank to be in a severe deteriorated condition, due to the poor surface preparation and waxing by the previous contractor. The spot about the size of a baseball proved to be a weilding blow-thru that had been filled with rod stubs, nails, and other foriegn matter and could have blown out at any time, causing a rip in the tank. Also, aprox. half way up the East side of the tank between the drainpipe and the ladder there is a buckle. The buckle is an inward buckle and should be checked periodically for creasing. If creasing appears then steps should be taken to correct as soon as possible.

Inspection of the outside of the tank showed that the caulking at the base of the tank had deteriorated allowing water to run under the bottom allowing a possibility of rust to eat thru the bottom. The paint on the outside of the tank had broken down in places to numerous to count. Rust was appearing every where. I found this to be caused by the numerous weilds that had been made inside by the previous contractor. Every place a weild was made inside, the outside paint had been burnt off. It is my opinion that they did nothing to the outside surface to protect against the burn off. They merely painted over them, trapping the rust, and in a

short time causing break thru in the paint.

Inspection of the valve room showed it to be in a badly deteriorated

condition.

I had the painting contractor put a 5 x 5 x  $\frac{1}{4}$  patch over the bad place in the tank. They scraped the remaining wax from the tank, then there was a white blast given to the inside. Then 3 coats of Pota- Pox paint was applied. (24 hrs. between coats) A final inspection was made and at my request touch ups was done to some of the weilding surfaces. There was an average of 8 mills of Pota-Pox paint inside the Greenville Water Tank. On August 29, after 7 days of curing time, the tank was sterliazed, a new gasket was put on the excess hole and was bolted shut and filling had begun. Nothing was done about the pitting inside the tank due to the fact that the Pota-Pox paint would be as good if not better than any weilding we could have done.

#### Outside of Tank:

The outside of the tank was blasted to almost near white, Two coats of primer was applied (24 hrs. apart) and 2 coats of enamel was applied (24 hrs. apart). New caulking was applied to the base of the tank.

The Greenville Flag and the name Greenville was painted on. The tank is

white, the lettering is green, and the top is blue.

The room containing the valves was blasted to near white, one coat of primer 37-77 and one coat of Pota-Pox 1255 & 1211 mix paint was applied. Our rating on the Greenville Tank for Workmanship and Paint Quality is

95 % perfection.

Work on tank was started on August 6, 1981, and was completed Sept. 7, 1981.

An audit of certain paid claims incurred between January 1, 1981 to April 1981 was conducted by Jack Sprigler, President of the Board. The audit indicated numerous Telephone long distance calls were made or received which were not business related and paid by the Water Utility. Additionally, purchases were made indicating similar payments.

Since these chages and payments indicate "personal" transactions Ms. Janice Gibson, the utility Office Manager, and person responsible for payment of claims was requested to review these claims and advise the board of such action. Ms. Gibson was advised the board considered them to be personal and since no reimbursement has been made she was subject to termination for misuse of ufnds.

Ms. Gibson was presented a list of these calls and purchases and asked to review which were hers. She responded she made or received calls and made purchases for perpsonal use amounting to approximately \$43.

As were charges in excess of this amount the Board President requested Mr. Getrost and Mr. Huckleberry to review the chages and to respond. The response was negative.

As Ms. Gibson has promised to reimburse the utility for personal calls and charges and to cease such practices immediately the board fells appropriate action has been taken. The board advised Ms. Gibson that should such incident happen again she would be subject to immediate dismissal.

This meeting was attended by Mr. Sprigler and Mr. V.J. Miller, Board Member.
