Terry Boaz opened the meeting. All members, James Harl, Robert Tilley, Chris Linton, Janice Gibson, Larry Webb, Vernon McKown, Wallace Miller, Ollie Sanders, Richert, And Talbot Richardson were present. The minutes from the last meeting were read and approved. Claims were presented and approved for payment. The treasurer's report shows a checking fund total as of June 30, 1975 is \$17,449.18. (General Fund \$3,908.81, Local Roads \$3,937.50, Street \$7,800.43 and C C I F \$1,802.44) The Revenue Sharing Fund has \$2,345.59.

Terry Boaz appointed a Water Steering Committee composed of: Vernon MCKown, Chairman, Wallace Miller, Ollie Sanders, Richert and Talbot Richardson. The committee's responsibilities are to recommend a job description of water personnel, recommend away scale for working, recommend a person or persons to fill the needs of the water company, and to give general advice on water matters. The committee is to give a report at the next meeting. The board will take appropriate action as it sees fit.

The board voted to raise the tap<sup>ing</sup> fee with the approval of the Public Service Commission application.

Chris Linton stated the lake needed some bulldozing work done. The board agreed to have it completed.

Robert Gibson moved and Wilodean Miller seconded that the day shift marshall's monthly salary be raised to \$200.00 and that the night shift salary be raised to \$150.00 effective January 1, 1976.

The board decided to advertise bids for a water storage building and a town office to be submitted on August 11, 1975. The board agreed.

The town convention will be August 25, 1975, at 8:00 P.M. at the Greenville School, Greenville, Indiana.
