

Gentlemen:

I have discussed this letter with David Eberenz, the Environmental Consultants, Inc. Inspector on Contract No. 2: Water System Expansion.

David Eberenz states that David Snyder asked him if Sakrete (pre-proportioned and mixed concrete in paper bags) could be used to encase the creek crossing instead of Ready Mix or Job Mix concrete. David Eberenz gave permission to use Sakrete for the creek crossing encasement, provided that all requirements of the Plans and Specifications were met. The inspector saw quantities of Sakrete stored at the crossing sites, but did not witness actual placement of the encasement, since placement was usually made after normal working hours.

Mr. Eberenz tells me that the Contractor did not request permission to place the unopened bags of Sakrete on and around the pipe in lieu of the specified and detailed encasement.

Some uplift or flotation occurs when the pipe is encased, as shown in the encasement detail D/10. Drawing No. 8. Good practice requires that the pipe be held in position while the concrete is being placed. This does not cause harmful stress.

With reference to Environmental Consultants, Inc.'s letters of 2 and 6 July 1982, inquiries by the Engineer and the Greenville Water Company indicate that the 12 inch PVC water line crossing of Jersey Park Creek and Little Indian Creek on the Southwest side of Highway 150 and the 6 inch PVC water line crossing a branch of Little Indian Creek may not have been adequately encased in concrete as required by the Plans and Specifications.

Due to serious difficulties in dewatering the trench, the Contractor, David Snyder's Backhoe and Trenching Service, placed unopened paper bags of Sackrete over the pipe to prevent segregation and washout of the cement.

I have enclosed pertinent correspondence and will discuss this with you in the near future.

Members of the Board:

Enclosed, please find a check for the amount of \$373.80 to cover the loss of water for Mr. Lenfert's service line. The replacement of the cast iron valve box on John Pectol Road is also complete.

I would like to relate the procedure used for the three creek crossings you requested additional work on. The process we used to concrete encase the water main was to place a sufficient number of bagged concrete on the line to give it a cased effect. This process was done in full agreement and supervision of the resident inspector, Dave Embrenz. A representative from Bob Igrigg's company also knew of this process from a previous project in Edwardsville, Ind. If these particular mains had been concreted as shown on the Engineering drawing, they would have been put in an extreme amount of stress.

We had discussed this process with Mr. Embrenz and we both agreed that in these instances with water problems, etc., this would provide equal or better protection for your lines. If we had been instructed by the inspector not to encase your lines this way, we would have been glad not to do so, as we went to a greater expense to encase them this way.

We are sorry that there has been a misunderstanding on this matter, as we have tried to rectify any problems with our work. I apologize for not being able to attend your last board meeting, but I have been working on a project in Evansville, Ind. and could not get away.

If you feel additional discussion is needed concerning this, please call me and we can set up a meeting with all those involved.

Gentlemen and Ladies of the Board, the writers have recently purchased the above property, formerly the property of Wally and Mrs. Miller.
