The regular monthly meeting of the Town Council was called to order by President Ted Miller with Council members Gerald Burkhart and Mike Receveur present; Ray] Gibson was absent. Also attending was the Clerk Treasurer, Gary Getrost, Marshal David moore, Craig Herron and Joy Purvis.

On motion by Mike Receveur the minutes of the August 11 and 26 meetings were approved 3-0.

Craig Herron, Herron Excavating Co., stated he would like to develop a lot at the intersection of US 150 and Buttontown Road inquiring if there are any restrictions as to the use. The Council informed him the Town did not have any ordinances restricting the use of such lots other than building size, lot set back and lot size. A copy of the Building Ordinance was given to Mr. Herron.

Mike Receveur advised the Council he had solicited bids by phone for street paving from Luther Paving and streigel Paving and Libs Paving and had received only one (1) response; that being from Libs Paving. After careful consideration the Council accepted the Bid of Libs Paving in the amount of \$24,350. (3-0).
