
Pursuant to Ordinance adopted by the Board of Trustees of the Town of Greenville upon the 12th day of October, 1982, certain billing practices of the Water Utility have been altered. In this regard, the following billing procedure has been established:

- (a) Your water bill will be due on the 1st day of each month and will become delinquent on and after the 15th day of each month.
- (b) A delinquency charge of 10% of the first \$3.00 and 3% of the excess over \$3.00, shall be charged with respect to delinquent accounts which are not paid on or before the 15th day of each month.
- (c) The non-payment of your account prior to the 25th day of the month will result in the discontinuance of water service.
- (d) In the event of a termination or discontinuance of water service, a re-connection fee of \$25.00 shall be charged and paid prior to the reinstatement of service.

The foregoing policies and procedures will be applicable with the billing period beginning November 1, 1982, notwithstanding the fact that these policies and procedures may be inconsistent with the information printed on the water bill. The water bill will be changed to conform with the foregoing at the time of the next printing.
