The regular monthly meeting of the Greenville Town Board, held this date, was opened by President Jack Sprigler. Present were all board members, Bob Isgrigg, Gary Getrost, Talbotte Richardson, Marvin Powell, Paul Buche, Don Jackson, and Elaine Miller.

The minutes of the previous meeting and the financial reports were presented to and accepted by the board.

Talbotte Richardson introduced Paul Buche and Don Jackson. He said Don had been helping him undercover on narcotics. Paul has been helping with record keeping. They both ride with Marvin and Talbotte. Talbotte requested the board add Paul and Don to the department as volunteers. The board will consider the request until the next board meeting.

Marvin Powell brought up the problem of the condition of the road at the lake. Gary Getrost was told by the board to contact Danny Cristiani about repairing the road.

Bob Isgrigg brought the new map of the town. He still needs to write the legal description. The map should be framed. Talbotte Richardson volunteered to make the frame.

Grace Martin announced the Election Petitions have been given to Bill Jenks.


Gary Getrost reported the water contract with Edwardsville is up for renewal. It is possible they will ask for a rate raise and a minimum. The water utility is not getting the minimum from Floyds Knobs, and are only being billed for what is used. This is due to Floyds Knobs not meeting their part of the contract during the summer.


Gary asked about the contract between Danny Cristiani and Munich (Environmental Consultants) on three crossings. The contract is for \$15 per lineal foot, and the work has never been done. The board decided it was a matter between Cristiani and Munich.

Gary also reported that Steve Hunt had water usage of 21,000 gal. over a 21 day period. He is requesting an adjustment, claiming something is wrong with the meter. The board told Gary to offer Steve the option of having the meter tested. If the meter is working properly, Steve pays for the testing and the water used.

The annual budget for the water utility was approved by the board.
