## ORDINANCE NO. 1982- 05

AN ORDINANCE AMENDING ORDINANCE NO. W-3 OF THE TOWN OF GREENVILLE, INDIANA, DATED THE 15TH DAY OF NOVEMBER, 1963

WHEREAS, on the 15th day of November, 1963, the Board of Trustees of the Town of Greenville, Indiana, adopted Ordinance No. W-3 pertaining to rates and charges for use of and services to be rendered by the Water Works System to be constructed by the Town of Greenville, which Ordinance was thereafter amended, from time to time; and

WHEREAS, the Board of Trustees of the Town of Greenville is presently desirous of further amending said Ordinance in the particulars as hereinafter set forth.

NOW THEREFORE:

BE IT ORDAINED, that the paragraph of Ordinance No. W-3 dated the 15th day of November, 1963 and entitled Collection or Deferred Payment Charge, be, and the same hereby is amended to read as follows:

All bills for water service not paid within fifteen (15) days from the due date thereof, as stated in such bills, shall be subject to a collection or deferred payment charge of 10% on the first \$3.00 and 3% on the excess over \$3.00. If the bill is not paid within ten (10) days of the date upon which a collection or deferred payment charge shall become applicable, service shall be disconnected. If reconnection thereafter occurs, a fee of \$25.00, shall be charged, which reconnection fee shall be in addition to any current charges then due, including any collection or deferred payment charge applicable thereto.
