The regular monthly meeting of the Greenville Town Board was opened by President Robert Gibson. Minutes of the previous meeting was read and approved. The monthly financial statement was presented to each board member. All Board Members were present, in addition to Ms. Una Hartfield, Virginia Ham, Jim Hartfield, Robert Tilly, Rick Lenson, Gary Getrost, Dan Cristiani and other interested persons.

Ms. Una Hartfield questioned the board if any zoning problems existed on a lot she was planning to sell. Mr. Gibson advised her that no zoning existed for the present time but he could speak only for the present board.

Jim Hartfield questioned the boards' appraisal of line customers in his area. He was assured that if the board found it feasible to extend the line to his area they would do so. Mr. Gibson stated that he would advertise for bids to extend the line in question and if favorable, extension would begin in the spring of 1978. This was agreeable to Mr. Hartfield. Mr. Hartfield at this time informed the board of various benefit plans he offered and stated he would gather figures on life insurance, hospitalization, and other costs for board consideration at a later meeting.

Mr. Ed Barnett of Midwest Engineering Company informed the board of the present status of the sewers for the town. He stated the basis for extending sewers as of now are somewhat changed from the last meeting with the board and he felt he would proceed according to the new guidelines.

On motion by Robert Gibson, seconded by Pearl Tush, Ms. Virginia Ham was appointed School Crossing Guard effective October 26, 1977 at a salary of \$50.00 monthly. At this time she was paid for four (4) days for October. November and each month thereafter she will be paid at the regular meeting of the town board. The board authorized payment on the first day of the month if conditions warranted.

Mr. Robert Tilly submitted his resignation as Town Marshall effective immediately. The board, on motion by Robert Gibson, seconded by Bill Voyles, accepted his resignation. By unanimous vote of the board Mr. Tilly was appointed Street Commissioner, on motion by Pearl Tush, seconded by Bill Voyles, at a salary of \$175.00/monthly. On motion by Robert Gibson, seconded by Pearl Tush the board established a uniform allowance of \$100.00 annually and appointed Mr. Tilly as an unpaid Town Marshall at which time Mr. Tilly was sworn in as the Town Marshall.

On motion by Robert Gibson, seconded by Bill Voyles, Mr. Marvin Sears and Mr. Terry Boaz were appointed Humane Officers for the Town of Greenville, at a salary of \$75.00 monthly. Both Mr. Sears and Mr. Boaz were appointed Deputy Marshall (unpaid) and were sworn in as such.

The board adopted the attached ordinance.

Mr. Dan Cristiani informed the board of back fill problems along the Galena-Edwardsville Road. He stated that work should be completed shortly providing the weather holds out. Mr. Cristiani informed the board that his charge for the Boring Machine would be a flat fee in the future. The board agreed for Mr. Cristiani to run a test of ten (10) borings @\$15.00 pr/hr to establish a basis for a flat fee to be charged.

No further business being before the board Ms. Pearl Tush made motion to adjourn, seconded by Bill Voyles.






