MINUTES OF TOWN COUNCIL MEETING
November 14, 2000

The Regular monthly meeting of the Greenville Town Council was called to order by presiding officer Ted Miller, with all Council Members present. Also attending was Clerk Treasurer Jack Sprigler, Utility Supt. Gary Getrost, Mike Arnold, Mark Trail, Jamie McKown and Reed Striegel.

The minutes of the October 2000 meeting was approved as written, after motion to dispense with the reading. (copies were furnished each attendee) by Mike Receveur, (5-0).

Mark Trail complained of drainage problems along his property on Pekin Rd. Trail presented photos of the area in question. Ted Miller stated he was meeting with a contractor to inspect several areas within the Town and advised Mr. Trail he will be on the agenda for the December 12 meeting, at which time the Council should have the problems and solutions identified.


Reid Striegel, Floyd County Health Department, requested the Council adopt a proposed FCHD ordinance updating State changes to the uniform Code Ordinance (91-III) to affect incorporated areas in Floyd County. Council President Ted Miller stated all members had copies for their review. Miller then introduced assigned Ordinance 2000 - G - 06, titled "An Ordinance Authorizing the Collection of Fees for Certain Services Performed by the Floyd County Health Department." There being no objections by those residents in attendance, Mr. Miller opened the floor for vote. All Council Members voted "aye", Miller casting an "aye" vote. Miller then declared Ordinance 2000 - G - 06 duly passed by the Council.

Council Member David Matthews apprised the Council of his research on Planning & Zoning procedures.

Council approved a Capital Improvement Plan for the Town of Greenville for the period, January 1, 2001 through December 31, 2003, (5-0), and Salary Ordinances G - 00 - 07 and G - 00 - 08, (5-0).

Council approved (5-0) claims for the Town & Utility. Council also reviewed and gave tentative approval (5-0), for the Fire Service Agreement with Greenville Township Fire Board and also discussed the expired Snow Removal Agreement with Kruer Seeding Company.

No further business coming before the Council, the meeting was adjourned at approximately 8:45 p.m.
