MINUTES OF TOWN COUNCIL MEETING  
DECEMBER 11, 2001

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller with Council Members Leon R. Gibson and Mike Receveur present. Members David Matthews and Hanzel Barclay were absent. Also attending was Jessica Kayrouz (Floyd Central High School student), Gary Getrost, Marshal David Moore, Mike Arnold (Clarion News), Elaine Evans and Cathy Trail.

Minutes of the November meeting was approved (3-0), with the following changes: "approximately 220 feet of water line along US 150/Stiller Rd. Corridor", on motion by Mike Receveur. This was made on advice of Gary Getrost (Utility Supt.).

Council approved (3-0) Transfer Ordinance G 2001-T-12.

Elaine Evans was present for the hearing on Ordinance G 2001-T-15, "An Ordinance Vacating a Public Alley", since she owns lots affected by the vacation. After the Council explained the vacation only included the alley between lots 32 and 45, she was satisfied the vacation would not affect her lots 47 & 48. The Council then voted to vacate the alley by a vote of 3-0 on motion by L. R. Gibson, since no suggestions and/or objections were received. All members voted "aye".

Council, by a vote of 3-0, made the following appointments for 2002:

Water Utility Supt. - Gary Getrost

Town/Utility Attorney - J. Fifer (Fifer Law Office)

The Council approved (3-0) Ordinance 2001 - W - 13, "An Ordinance Providing for the Wages for the Employees of the Town of Greenville". All Council Members present voted "Aye".

Clerk Jack Sprigler stated he appointed Sheila Moore as Deputy Clerk Treasurer on a part time basis to act on his behalf for the year 2002.

The Council approved, 3-0, Ordinance G 2001 - T - 14, "An Ordinance Providing for the wages for the Employees of the Town of Greenville". All Council Members present voted "Aye".


Gary Getrost apprised the Members of the status of projects affecting the Utility.
