

MINUTES OF TOWN COUNCIL MEETING
DECEMBER 12, 2000

The Regular monthly meeting of the Greenville Town Council was called to order by presiding officer Ted Miller, with all Council Members present. Also attending was Utility Supt. Gary Getrost, Janice Gibson, Sheila Moore, Jef Fifer, Jamie McKown, James Curry, Mark Arnold, Dave Kruer and Town Marshal David Moore.

The minutes of the November-2000 meeting were read and approved as written. (5-0).

Jef Fifer presented the board with copies of the information sent by Danny Cummins' doctor. He stated all questions on the form were answered except whether or not Danny could return to work. Ted stated that he felt that Danny should be terminated. Possible termination will be discussed at the January meeting.

Dave Kruer presented prices for snow removal, for a new 3 year contract. The contract was accepted. (5-0).

Council was presented with the estimates from Seal Pro Coatings and Herron Excavating for the repair of the alley behind Papines and west of Greenville-Georgetown Rd. It was decided to hold the proposal until March or April.

Town Marshal David Moore informed the Council of a recall on the Jeep for the brakes and reminded the Council of the need to decide on the Personnel Policy. The proposal will be reviewed at the January meeting.

The Charge offs for the Water Utility were accepted by a 5-0 vote. Gary Getrost brought up the possible increase of the meter deposits. This will be discussed again at the January meeting. Janice Gibson brought up the need to increase the returned check charge.

The Council decided that the Water Utility Employees would not received any pay increases for the coming year with a 5-0 vote. Benefits for Sheila Moore will be discussed at the January meeting.

David Matthews discussed his research into zoning and informed the board that at this time Greenville does not need zoning, but did suggest that current Ordinances be reviewed and be made available in binder form to all Council Members.

The Council signed the agreement with the Fire Board.

Council approved (5-0) claims for the Town & Utility.

No further business coming before the Council, the meeting was adjourned.
