Public Hearing; Preliminary Engineering Report submittal and review for SRF Funding Loan for Water Tower.

Notice of Public Hearing was published in the New Albany Tribune on 12-3-2010. The publication of record for Floyd County Indiana {IC 5-3-1} Presentation was made by Aaron Sutherland, P.E. of the Preliminary Engineering Report prepared by Jacobi, Toombs and Lanz, Inc. Consulting Engineers and Land Surveyors. Discussions were held and suggested changes made for the finalized PER to be passed by an Acceptance Resolution at the January 10th, 2011 Monthly Meeting.
