A special meeting was held pursuant to letters written to each Board member dated December 13, 1976, by Rita Tucker for the purpose of appointing a clerk-treasurer for the remaining term of January 1, 1977, through December 31, 1979.

It was the unanimous decision of the Board to appoint Mr. Jack Sprigler to the position of Clerk-Treasurer effective January 1, 1977. Mr. Sprigler's office will be maintained in the Water Utility Office.

It was also decided at this meeting that effective January 1, 1977, Janice Gibson's position with the Water Utility is to become a salaried job rather than hourly. No increase in salary results in the change. In addition, Janice Gibson will be paid a salary every two weeks instead of once a month. Too, she is now entitled to:

- 1) Two Weeks Paid Vacation Each Year (this particular entitlement was previously agreed upon by the Board and appeared in previous Minutes)
- 2) Five (5) Sick Leave Days Each Year (not to be accumulated)
- 3) Three (3) Personal Business Days Each Year (not to be accumulated)

Robert Gibson moved the meeting be closed.




Please accept this letter as notification of my resignation to the Office of Clerk-Treasurer for the Town of Greenville effective January 1, 1977.
