

Minute June 8, 2020

Minutes of Greenville Town Council Meeting June 8th, 2020

President Greg Redden called the regular monthly meeting to order via Zoom meeting. Other Councilpersons present were Andy Lemon, David Gomes, and Skip Powell along with Clerk Jack Travillian. Also attending the meeting were Chief Craig, Town Attorney Heather Peters, Greenville Water Superintendent and Audi Findley.

Minutes: The minutes for May 11th regular meeting was discussed. Motion was made by councilman Gomes and seconded by President Redden to accept the minutes. Motion passed 4-0.

Police Report:

Chief Craig noted the backup camera system will be installed in the K-9 patrol vehicle the unit has been purchased.

Notes from the citation for the property on Highway 150 at East 5th street, the grass was mowed the next day, however there was a trash issue, Chief Craig will follow up.

One of the patrol cars is still in need of repairs however the officer has been activated in military service and will get the repairs completed when he is back.

There was a dog bite on Buttontown Road, the department is still looking for the big black dog and there has been an alert sent to all police departments asking to quarantine the dog upon locating.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The checks were approved. Motion made by President Redden and seconded by Councilman Gomes for reconciling form for April 2020. Motion passed 4-0.

Committee Reports:

Emergency Services:

The police department does have ample supplies for PPE (Personal Protective Equipment) and should be good for the foreseeable future.

Streets and Roads:

Councilman Lemon presented a cost benefit analysis for paving Pekin Road and Voyles Road with Floyd County. Motion was made by Councilman Lemon and seconded by Councilman Powell to spend \$7,500 from the MVH Reserve Fund and \$11,454 from Riverboat Fund. Motion passed 4-0. The council will contact the paving contractor about possibly adding 40 foot of payment to Arthur Coffman Road at Pekin Road.

The seal coating bids for Heritage Springs were reviewed, one for \$22,000 and the more extensive service for \$40,000. The council will study and decide at a later time.

Wind Dance entrance is having pavement issues and possible drainage problem. The council is still reviewing and may add this to the next round of Community Crossing Grant.

Special Projects:

The town has received a letter of accomplishment from the Floyd County Parks Department for the installation of the new drinking fountain and new signage. Councilman Lemon is working on additional signs requested to keep consistency.

Attorney:

The next town council meeting may be held in person according to the Governor's time table. The cable company franchise fees are being reviewed about exclusivity clause. This is due to interest by Mainstream filer to install wiring and offer service to town residents.

New Business:

Requested from business Four R Solutions located at 7202 Voyles Road to send notice to State of Indiana about zoning of area as light industrial to continue as a certified scrapping processor. The town's future land use map has this designated. The business should fall under IDEM (Indiana Department of Environment Management).

Resident Heather Gauraye requested closure of Heritage Way on July 4th from 8 PM to 12 AM for a fireworks show and clean up after the event. The Greenville Fire Protection District will try to have a truck on standby at the event. President Redden made a motion and Councilman Gomes seconded. Motion passed 4-0.

Utility Business:

Water Utility

Superintendent Audi Findley sent his monthly report to the council before the meeting and there was no questions. The leaks and adjustment report was presented and accepted with no questions.

Superintendent Findley requested continuing the pandemic response through June and into July. The utilities have adequate PPE (mask and sanitizer). Attorney Peters suggested waiting until after July 4 at least. The council agreed to install glass barricades in the office to protect workers. Superintendent Findley will apply to recover the cost of recovery from the State or Federal government.

Superintendent Findley presented a proposal by Indiana Department of Traffic about moving water lines in the Highway 150 right-a-way. The cost will be capped at 10% of annual income (\$150,000) with an additional upgrade to 8" line cost of \$30,000. He requested signing a contract for engineering for \$22,000. The council will review and decide at next meeting.

The Suez contract for tank maintenance is under review and be decided at the July meeting.

Minute June 8, 2020

Motion was made by Councilman Lemon and seconded by President Redden to sign off on the easement agreement on Pekin Road with Linda Kepley for the new pumping station upgrade. Motion passed 4-0.

Superintendent Findley presented estimate to seal coat the town's/utilities' parking lot at a cost of \$1,758. Motion made by Councilman Gomes and seconded by Councilman Lemon. Motion passed 4-0.

Superintendent Findley requested selling the old phones for \$1 to employees and their family. Councilman Lemon will prepare a resolution.

Sewer Utility:


