Minutes of Greenville Town Council Meeting April 8th, 2024

Monthly Meeting:

President Greg Redden called the regular monthly meeting to order. The other Councilpersons present were Andy Lemon, David Gomes, and Skip Powell. Also present were Acting Town Marshal Carmen Kerberg, Superintendent Steven Webb, Utility Office Manager Crystal Robb, and Clerk Jack Travillian. Other concerned citizens were also present. The meeting began with the Pledge of Allegiance.

Minutes: Motion made by President Redden and second by Councilman Powell to accept the minutes for March 11, 2024. Motion passed 4-0.

Police Department: Acting Town Marshal Carmen Kerberg has gotten the K-9 unit removed from the new police vehicle. The town will be accepting bids for the slightly used kennel fitting the Ford unit. Bids will be opened at next month's meeting. Both Dodge Charger vehicles require repairs, but they will need to be towed. The council approved having the repairs completed to decide which should be kept as the reserve officer vehicle. The council left it to the Marshal's discretion where to get the repairs done. The other will be sold via bids.

The Chief's convention will be coming up soon. The council approved attendance with the receipts being used for reimbursement. Executive session will be held on April 22 at 7 PM to review the applications for the vacant Marshal position. Motion by President Redden and second by Councilman Lemon to spend up to \$300 for training ammo to be purchased from Triple G gun shop. Motion approved 4-0.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The council approved monthly checks.

Committee Reports:

Emergency Services:

The council has heard continued complaints about speeding on Schuler Road caused by the construction on Highway 150. This road is not in Town Limits so must be addressed by Floyd County officers or State Police officers.

Zoning issue concerning the request for a variance allowing additional business in high traffic area around Parkland Heights and Heritage Springs. Floyd County Zoning Commission will be forwarding their findings to the council.

Streets and Roads:

Council Member Powell requesting review of damage to curbing in Wind Dance Subdivision just off Highway 150.

There are a few missing street signs, and the council will review this issue.

Property Cleanup:

The property in the 9800 block of Clark Street has complaints about garbage and other issues and has been referred to the Floyd County Health Department for follow up.

Special Projects:

The first weekend of June will be the town wide community yard sale this year.

First Harrison Bank representatives were present with a proposal bid for upgrading to new rates. The council will review and award at next month's meeting.

Attorney Report:

Town Attorney Peters is reviewing a new interlocal agreement regarding animal control.

Motion by President Redden and seconded by Councilman Gomes to close town business, motion passed 4-0.

Utility Business:

Water Utility

Superintendent Steven Webb presented the leak adjustments report which was reviewed and accepted by the council. March water loss was 16%. The staff continues looking for any leaks.

Rate Increase pass through for Indiana American rate increase; There will be a Public Hearing on April 22, 2024, at 6:30 at Greenville Town Hall.

Galena Commons has a new plan design from ARC presented to the council.

Office Marager Cystal Robb has hired a new part time office worker.

Sewer Utility:

A blower at the Heritage Springs Watse Water treatment plant got extremely hot, so the lines are being ran through water for cooling purposes.

No further business coming before the Council, motion made by Councilman Gomes and second by Councilman Powell to adjourn the meeting. Motion passed 4-0.
