**Minutes of Greenville Town Council Meeting
November 9th, 2020**

President Greg Redden called the regular monthly meeting to order via Zoom meeting. Other Councilpersons present were Andy Lemon, David Gomes, Kyle Kruer and Skip Powell along with Clerk Jack Travillian. Also attending the meeting were Police Chief Craig, and Town Attorney Heather Peters.

Minutes: The minutes for October 12th regular meeting was discussed. Motion was made by Councilman Gomes and seconded by Councilman Powell to accept the minutes. Motion passed 5-0.

Police Report:

Chief Craig submitted the SOP for the Greenville Police Department to the council for consideration. President Redden is making some adjustments and it is being reviewed by Attorney Peters.

Chief Craig reported that the 4 sets of body armor from Galls for around \$4,000 per set have been ordered.

Chief Craig reported on the need for replacement of furniture and equipment damaged by the water (roof leaks).

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. Motion was made by President Redden and seconded by Councilman Lemon to approve. Motion passed 5-0.

Committee Reports:

Streets and Roads:

Adam Dickey from HMB was present and offered a bid for \$23,008 maximum to prepare the Community Crossing application with project PHAZER report. Motion made by Councilman Lemon and seconded by President Redden. Motion passed 5-0.

The Stop sign has been installed in Heritage Springs. The council has received requests to install speed bumps to reduce the speeding in Heritage Springs. Councilman Lemon will prepare proposal for rubberized and removable hump. Must review signage for project.

Property Cleanups:

The council request Chief Craig issue daily citation for the Dollar General's trash issue.

Special Projects:

Councilman Lemon reported on the Norman Coleman sign dedication held on November 1, 2020 at Greenville Elementary School. There is a video posted for the ceremony.

Attorney Report:

Attorney Peters is reviewing SOP submitted by Police Chief Craig and Greenville Water Utility.

2020-TR-018 REPLACEMENT OF DAMAGED EQUIPMENT AND FURNITURE Motion was made by President Redden and seconded by Councilman Gomes to allow Chief Craig to spend funds that are received from insurance claim. Spending shall not exceed amount in possession of town. Motion passed 5-0.

Utility Business:

Water Utility

Superintendent Findley was on repair run for damaged main water line and not available for the meeting. Water adjustments were reviewed and accepted.


Councilman Lemon is working with River Hills Economic Development District to complete an income survey, which is the first step for applying for grants. Estimated cost of \$2,000.
