**RESOLUTION AUTHORIZING THE PURCHASE OF COMPUTER
STATIONS FOR THE GREENVILLE WATER UTILITY**

WHEREAS, the Town Council and Greenville Water Utility Council for the Town of Greenville, Indiana is desirous to provide the latest in Computer Technology and consistency in computer stations for the employees of the Greenville Water Utility be it ordained as follows;

A. The Water Utility Superintendent is authorized to spend a sum not to exceed Eight Thousand U.S. Dollars {\$8,000.00} for {4} Dell Computer work stations. Each station is suggested to consist of the following;

2. One Station shall be used by the Assistant Water Utility Superintendent
3. One Station shall be used as a stand alone station to be used by the public for viewing of Ordinances, Resolutions and Monthly Minutes that are in electronic form. A stand a lone Dell 1110 Laser Printer shall be purchased to use with this station.
