**ORDINANCE CONCERNING AUTHORIZATION FOR THE PURCHASE  
OF A 2011 CHEVROLET SILVERADO SR WORK TRUCK FOR THE  
GREENVILLE WATER UTILITY OF THE TOWN OF GREENVILLE,  
INDIANA**

WHEREAS, the Town Council and Water Utility Council for the Town of Greenville, Indiana, is desirous to provide the Greenville Water Utility with replacement equipment for better operation of the Greenville Water Utility.

WHEREAS, the Town Council and Water Utility Council for the Town of Greenville, Indiana, is authorized by I.C. 5-22-10-1 and I.C. 5-22-10-5 to make a special purchase when there exists a unique opportunity to obtain supplies or services at a substantial savings to the governmental body without competitive bidding even though the purchase may be over \$25,000.00 US Dollars.

WHEREAS, John Jones Automotive Group located in Greenville, Indiana has submitted a proposal to the Greenville Water Utility of Greenville, Indiana to purchase a 2011 Chevrolet Silverado 3500HD 4WD Reg. Cab 133.7" SR Work Truck with optional equipment at a discounted price of \$10,890.00 US Dollars {MSRP \$43,790.00 US Dollars}.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN AND WATER UTILITY COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. After passage of this Ordinance the Greenville Water Utility Superintendent shall issue a purchase order to John Jones Automotive Group of Greenville, Indiana for a 2011 Chevrolet Silverado 3500HD 4WD Reg. Cab 133.7" SR Work Truck with optional equipment for \$32,900.00.
2. The Greenville Clerk/Treasurer shall issue a check in the amount of \$32,900.00 to John Jones Automotive Group to accompany purchase order in accordance with John Jones Automotive Group Quote attached prepared by Scott Rose on February 21<sup>st</sup>, 2011.
3. The John Jones Automotive Group shall provide to the Greenville Water Utility a receipt for proof of purchase and State of Indiana Motor Vehicle Title of ownership to the Greenville Water Utility.
4. The Greenville Clerk/Treasurer shall charge the purchase of the 2011 Chevrolet Silverado 3500HD 4WD Reg. Cab 133.7" SR Work Truck with optional equipment for \$32,900.00 as a credit against the Greenville Water Utility Special Project Account.
