**ORDINANCE CONCERNING THE SALARY ADJUSTMENTS,  
TRANSFER OF FUNDS AND ESTABLISHING OF NEW BUDGETED  
ACCOUNTS FOR THE GREENVILLE MARSHAL'S DEPARTMENT OF  
THE TOWN OF GREENVILLE, INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana, per a request by the Town of Greenville Marshal David Moore, Committee Chair of Emergency Services Councilman Bob Wright and the Greenville Town Council President Talbotte Richardson are desirous to pass this Ordinance for Salary Adjustments and Establishing New Budgeted Accounts for the Greenville Marshal Department of the Town of Greenville, Indiana;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The following New Accounts and Accounts Numbers shall be created under the Budget General Fund and appear on the March Monthly Budget Sheet submitted by the Greenville Town Clerk.

- Marshal Department Detective Payroll {Account Number to be Assigned}
- Marshal Department Life Insurance Fund {Account Number to be Assigned}
- Marshal Department Reserve Payroll {Account Number to be Assigned}. These Funds can be transferred through Ordinance if required to be used as needed within the Marshal Departments Operating Requirements.

2. The following Salary transfers shall be effective upon passage of this Ordinance.

- Account Number 101001113 Marshal Payroll shall be changed from Budgeted Twenty Six Thousand U.S. Dollars and No Cents {\$26,000.00 U.S.D.}, to Budgeted Fourteen Thousand U.S. Dollars and No Cents {\$14,000.00 U.S.D.} effective as of January 1<sup>st</sup>, 2010.
- Account Number 101001113 Marshal Payroll Budgeted original amount of Twenty Six Thousand U. S. Dollars and No Cents {\$26,000.00 U.S.D.} shall have Eleven Thousand and No Cents U.S. Dollars {\$11,000.00 U.S.D.} transferred to Marshal Department Detective Payroll {Account Number to be Assigned}.



- Account Number 101001113 Marshal Payroll Budgeted original amount of Twenty Six Thousand U. S. Dollars and No Cents {\$26,000.00 U.S.D.} shall have One Thousand U. S. Dollars and No Cents {\$1,000.00 U.S.D.} transferred to Marshal Department Life Insurance Fund {Account Number to be Assigned}.
- Account Number 101001115 Deputy Payroll Budgeted Amount Remaining as of March 1<sup>st</sup>, 2010 shall have One Hundred U. S. Dollars and No Cents {\$100.00 U.S.D.} transferred to Marshal Department Insurance Fund {Account Number to be Assigned}. Balance of Funds shall be transferred to Marshal Department Reserve Payroll {Account Number to be Assigned}.
- Account Number 101001115 Deputy Payroll Budgeted Amount shall show a Remaining Balance as of March 1<sup>st</sup>, 2010 as Zero U. S. Dollars and No Cents {\$0.00 U.S.D.}
