

Minutes of Greenville Town Council Meeting July 12th, 2021

Regular Monthly Meeting:

President Greg Redden called the regular monthly meeting to order. Other Councilpersons present were David Gomes, Kyle Kruer and Skip Powell along with Clerk Jack Travillian. Also attending the meeting were Greenville Police Chief Justin Craig, Greenville Water Superintendent Audi Findley, and Town Attorney Heather Peters.

Minutes: The minutes for May 10th and June 14th regular monthly meetings were discussed. Motion made by President Redden and seconded by Councilman Powell. Motion passed 4-0.

Utility Business:

Water Utility

Superintendent Audi Findley sent his monthly report to the council before the meeting and there were no questions. The leaks adjustments were accepted.

Fund Management:

Council is working with Baker Tilly CPA firm to complete the financial audit and long term planning. The council requested immediate attention on any requested due to this being an hourly charge for services.

Swif Grant:

Superintendent Findley will be completing and summiting all portions of this grant application.

Heritage Springs Waste Treatment Plant recommendations:

Matt with Heritage Engineering gave an evaluation about proposed maintenance and upgrade projects for Heritage Springs Waste Treatment Plant. There were several options to choose from on how extensive the project will need to be completed. The council will make a decision soon.

Hydrant Project:

Superintendent Findley will be doing maintenance of all existing hydrants. A request was presented to the council about adding a meter to track usage for fire station in Galena for tracking purposes. The cost is not reasonable for the benefit of better tracking for water losses at this time.

New Truck:

The age and mileage of some of the fleet of the water utility vehicles is becoming a concern to the Superintendent, therefore the council requested getting estimates for replacement truck.

Electronic time clock application was approved with additional questions about manual override, how many terminals could be used, can remote access be used from smart phones?

Waste Water Plant:

The permit requirement has been completed and should not have any issues due to the plant not running at capacity. Recommendation to bring secondary holding tank online was suggested.

Ordinance 2021-WO-010: STANDARD PROCEDURE FOR CONSTRUCTION FOR GREENVILLE WATER UTILITIES OF GREENVILLE INDIANA: Second reading was completed. Motion by President Redden seconded by Councilman Gomes. Motion passes 4-0. Third reading was completed Motion by President Redden seconded by Councilman Gomes Motion passed 4-0.

Josh Norman appeared before the council and requested installation of an antenna to the Greenville Water Utility water tower, to offer another option for Internet connection for anyone in line of sight with the tower. It is a microwave signal with cost averaging from \$45-\$85 per month per customer. The council approved with review of the contract and service in exchange for monthly fee.

Police Report:

Police Chief Craig gave his report about monthly activity. Chief Craig noted that the gun permit fee was repealed by the state legislators removing as of July 1, 2021.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The checks were approved.

Committee Reports:

Streets and Roads:

The council noted that most of the 2021 Pot Hole Blitz has been completed.

The council has received a request for center stripes to be completed on Greenville/Georgetown Road. This should also be completed on Voyles Road and Pekin Road if deemed possible. Council is awaiting pricing options.

Old Business:

Ordinance 2021-TO-007 ESTABLISHMENT OF ARP ACCOUNTS FOR TOWN OF GREENVILLE: First reading was completed. Motion for unanimous consent by President Redden and seconded by Councilman Powell. Motion passed 4-0. Second reading was completed. Motion by President Redden seconded by Councilman Powell. Motion passes 4-0. Third reading was completed Motion by President Redden seconded by Councilman Powell Motion passed 4-0.

No further business coming before the Council, motion made by Councilman Gomes and seconded by councilman Kruer to adjourn the meeting. Motion passed 4-0.
